APPARATUS & EQUIPMENT:

Chief Lingenfelter Reported:

- Truck 405 damage occurred to the rear of the apparatus has been scheduled for repair. A check from the insurance company has been received less the \$500 deductible.
- We are due to replace a chief's SUV. The vehicle to be replaced is a 2002 Chevy Blazer. <u>Based on current state contract pricing for the Chevy Tahoe and similar emergency lighting</u> <u>packages. I am requesting authorization to order a 2013 Chevy Tahoe, emergency lighting</u>, <u>lettering, and storage unit at a cost not to exceed \$42,000.</u> Also, based on the current color of utility vehicles in District # 2 and Stamford Heights I would also like to request we change the color to red with gold lettering which would match the pick-up trucks. A permissive referendum will be required to utilize apparatus reserve funds.
- The tires on Engine 402 are due for replacement. They are 1 year past the NFPA recommended replacement cycle and are showing signs of dry rot. <u>I am requesting authorization to have the tires</u> replaced at a NYS contract price of \$3,486.76 by PCI Distributors, Inc.
- <u>Based on the lack of interest in someone buying E-403 I would ask the Commissioners to consider</u> <u>donating it to a Fire Department in need.</u>

Commissioner Woehrle Reported:

• A proposal from Monolith Solar Associates, LLC for the installation of a solar PV system under a NYSERDA incentive program has been received and is pending review.

Chief Lingenfelter Reported:

- The temperature control issues in the duty offices and duty quarters have been resolved. Seasonal adjustments will likely be needed in the fall and spring.
- Due to the changes in building access and parking configuration with the station renovation, we will need a walk behind snow blower to aid in snow removal. <u>Based on recommendations of staff and</u> vendor pricing I am requesting authorization to purchase an Ariens Professional 28" snow blower at <u>a cost of \$1,575.00.</u> Funds would be taken from the renovation budget.

• The old workout machines (stair master and elliptical) need to be declared surplus. I researched the value and I recommend they be auctioned off internally in as is condition.

- Bunkoff General Contracting has completed the final punch list as of 12/7/12. The attorneys are verifying the bonding of the liens and will be releasing the funds in escrow with Couch-White.
- The station renovation project was submitted to Fire Chief Magazine by Pacheco Ross Architects. Our station received a "Gold Award" in the fire station renovation category. The 2012 Station
