## **Treasurer Splendido Reported:**

 I received the estimates to calculate 2018 budget costs including Workers Compensation \$82,000.less than last year. Thus far, we are below the 1.8% tax levy with 1.23% and a net change of 2.9%.

### **APPARATUS & EQUIPMENT:**

## **Chief Lingenfelter Reported:**

- Engine 402 completed and passed the pump test on Saturday with the City of Schenectady Fire apparatus testing.
- Our 2005 and 2006 chief's Tahoes are experiencing frequent need for repairs and are in need of replacement. We are also in need of replacing our 2008 Sierra pickup truck. Pricing has been obtained from Denoyer Chevrolet which is accessible through a "piggy-back" clause in the Midway Fire District's bid specifications. Pricing is as follows:
  - 2018 Chevrolet Tahoe SSV \$40,653.00
  - 2018 Chevrolet Silverado \$35,419.50
- A trade-in deduction of \$2400 for each of the Tahoes being replaced.

A trade in value for our 2008 Sierra Utility 421 has not been obtained yet. Outfitting the three vehicles with emergency lighting, sirens, radios, striping and lettering is estimated through Specialized Vehicle Up-fitting at \$12,000 for the Tahoe's and \$10,000 for the Silverado totaling \$34,000.

I <u>am requesting authorizing a permissive referendum in the amount of \$150,000 for the purchase and outfitting of two 2018 Chevrolet Tahoes and one 2018 Chevrolet Silverado for use as emergency response vehicles.</u>

I am requesting authorization to order three nozzles at a cost not to exceed \$2800.

## **REPORT OF THE CHIEFS:**

### **Chief Lingenfelter Reported:**

- Firefighter/Paramedic Seiden has passed pre-employment screening and started work on September 5<sup>th</sup> 2017. He is currently working through initial training on our equipment and operations as well as Building Safety Inspector certification through the NYS Division of Building Code Enforcement.
- The 2017 Poster Shows in the schools is under way. All assemblies have been scheduled. The
  Poster Show program is done in cooperation with Niskayuna Fire District 2, Rexford Fire District,
  and the Niskayuna School District.
- Planning for this year's Annual NFD 1 / NFD 2 Halloween Party is in progress.

- The Niskayuna Coop is hosting a Firehouse Chili Contest on Saturday November 4<sup>th</sup>. NFD 1, Rexford, NFD 2, and Stanford Heights are participating.

- <u>I a\m requesting authorization for the Treasurer to draft four checks in the amount of \$50.00</u> payable to each of the four elementary schools to defray the cost of art supplies used during fire prevention programs at the schools.
- I am requesting authorization for Lt. Griffiths and FF Persons to attend state training programs for Engine and Truck Company operations totaling 56 hours of overtime and use of a district vehicle. Programs are being delivered regionally in November and December. This is a budgeted expense.

Motion/ Nappi, Second/ Weitz: To approve Ray Adelpegba of 1340 Van Antwerp Rd. Niskayuna, NY 12309 as a probationary Firefighter member pending screen testing and a complete physical. Passed 3-0.

Motion/ Nappi, Second/ Weitz: To grant extended sick leave to FF/P John Baker until November 8, 2017. Passed 3-0.

Motion/ Nappi, Second/ Weitz: To authorize Chief Lingenfelter to purchase three (3) nozzles at a cost not to exceed \$2800. Passed 3-0.

Motion/ Nappi, Second/ Weitz: To authorize Lt. Sims to attend the Fire Marshalls and Inspectors Seminar at Montour Falls Fire Academy from October 17<sup>th</sup> thru 20<sup>th</sup> at a cost of \$176.00 for registration, lodging, and meals, 24 hours of overtime and mileage for personal vehicle /or rental car. Passed 3-0.

Motion/ Nappi, Second/ Weitz: To authorize Lt. Griffiths and FF Persons to attend state training programs for Engine and Truck Company operations totaling 56 hours of overtime and mileage for personal vehicle. Passed 3-0.

Motion/ Nappi, Second/ Weitz: To authorize the Treasurer to draft four checks in the amount of \$50.00 payable to each of the four elementary schools to defray the cost of art supplies used during fire prevention programs at the schools. Passed 3-0.

Motion/ Nappi, Second/ Weitz: To authorize spending up to \$3,000.00 for minor repairs needed at The Balltown Rd. station. These repairs were noted in the 2017 Inspection report. Passed 3-0.

<u>Motion/ Nappi, Second/ Weitz:</u> To authorize Lt. Sweet to attend the Firehouse Expo in Nashville, TN from October 17<sup>th</sup> thru 21<sup>st</sup> at an estimated cost of \$2355 including registration, transportation, lodging, and meals. Passed 3-0.

Motion/ Nappi, Second/ Weitz: To allow The GBFC to utilize and chief's car and 1 piece of district apparatus for the Schenectady Holiday parade. Passed 3-0.

Motion/ Nappi, Second/ Weitz: To authorize up to \$100 for registration(s) to The Association of Fire Districts of the Capital Area fall workshop being held November11, 2017 at Boght Corners Fire Station. Passed 3-0.

<u>Commissioner Woehrle</u> reported that he will e-mail the commissioners a social media policy for a vote to take place during the November 2017 meeting.

<u>Commissioner Woehrle</u> reported that the new sign installed at River Rd. has been turned off and the company was called because of software needed.
