Commissioner Pacheco Reported:

- Chief Lingenfelter and I met with our insurance agent John White, to review our current policies. There were some easy changes made.
- There was a discussion about our Employee Dishonesty Coverage and Employment Practices.
- Commissioner Pacheco also discussed full replacement value building insurance for The Balltown Rd. Station. He recommended we increase that policy from 5 million dollars (\$5,000,000.00) to 7 million dollars (\$7,000,000.00) with an additional cost of \$970.00 annually.
- Additionally, Commissioner Pacheco stated that The River Rd. station is properly insured.

REPORT OF THE CHIEFS:

Chief Lingenfelter Reported:

- The Staffing for Adequate Fire and Emergency Response (SAFER) grant application was completed and submitted requesting funding for two additional firefighter/paramedics. Letters of support were requested from Senator Schumer and Senator Tonko's offices.
- Commissioner Pacheco and I met with John White and Deb Darmetko from the One Group regarding our insurance renewals.
- Ask Commissioner Woehrle to request the current eligible candidate list from Civil Service for Firefighter/paramedics and begin the process of canvassing candidates and conducting CPAT if needed to generate a certified list for hiring.
- 7 members will be attending The Active Attack Integrated Response Course (AAIR) course in Watervliet this Thursday and Friday. It is a 16 hour performance level direct delivery course designed to improve integration between law enforcement, fire, tele-communicator and emergency medical services (EMS) in active attack / shooter events.
- We have been experiencing an increase in EMS responses to cover for the lack of Mohawk Ambulance availability. Will be meeting with SFD and Mohawk Ambulance next week to discuss.
- NFD 1 was called in to assist with and Engine to two recent fires in the City of Schenectady. No
 injuries to our personnel and operations went smoothly. Engine 401 did make contact with a
 civilian's vehicle while maneuvering on scene and a police report was generated. The vehicle had
 left prior to us being made aware of the incident so the extent of damage if any is unknown.
 Insurance company will be notified should they file a claim. No damage was sustained to the
 engine.

- Request authorization for the chief to enter into a mutual aid agreement with Duanesburg Ambulance Corps. For provision of emergency medical services.
- Request authorization to attend the Volunteer and Combination Officer Symposium in Clearwater

 Beach from November 14th thru 17th at a cost of \$2135.00 including registration, lodging, travel, and meals. Conference request form has been submitted.
- 2019 year to date incident participation report is attached. Approximately 17% of the incidents had no volunteer response.

- We have many activities requiring coverage; including Niska-day, Pedal, Paddle and Run and the Cherry blossom Festival.
- I will be attending The NYS Chief's Convention and attending a class there. I would like permission to utilize a district vehicle for travel.
